2014 HOUSE LOG PERMIT SPECIAL CONDITIONS

- 1. Stump heights shall be left no greater than 6 inches above the ground.
- 2. All tree parts (slash) greater than 4 inches in diameter shall be removed by the applicant.
- 3. All slash less than 4 inches in diameter shall be cut into lengths no greater than 2 feet and will be scattered over the site, not to exceed 2 feet in depth.
- 4. Each timber cutting and use application must be approved, and a permit must be issued before any cutting or removal of timber from Corporation land is allowed.
- 5. There is a \$5.00 per log charge for house logs for non-shareholders.
- 6. No more than 200 house logs per application will be approved.
- 7. The cutting of house logs will be approved only from Corporation approved sites (listed on page 3 and marked on attached map.).

INDEMNIFICATION: APPLICANT'S FITNESS AND EXPERIENCE:

1. The applicant agrees to indemnify TKC and to hold TKC harmless from and against any and all losses, expenses, damages, claims, demands, fines, charges, liens, liabilities, penalties, enforcement actions, and causes of action or proceedings of any kind whatsoever (whether or not arising on account of damage to or loss of property, or injury to or death of any person) which may directly or indirectly arise or result from any operations or activities of the applicant occurring or authorized or purporting to be authorized under this permit.

The applicant represents to TKC that he/she is fit, willing, and has sufficient prior experience to undertake the activities authorized by this permit, that he/she is familiar with the physical requirements and hazards, whether natural or other otherwise, which are inherent in the activities authorized under this agreement, and that he/she specifically recognizes and acknowledges that the use of mechanical equipment, including chain saws, axes and tracked and wheeled vehicles in this activity involve inherent potential risks to life, limb, and property if not properly and safely handled by persons experienced in these activities. The applicant and its signatory to this permit, by his/her execution of this agreement, represents to TKC that he/she, and any other party assisting him/her with the activities are sufficiently experienced to enable the authorized activities to be conducted reasonably and safely, with due regard for the protection of persons and property. The \$5.00 fee per log is waived for shareholders.

CORPORATION APPROVAL:

This permit is valid for one year from the date of approval and may be cancelled by the Corporation if it appears to the Corporation that the information supplied by the Applicant is incorrect, or if it appears to the Corporation that the terms and conditions of this permit have not been met by the Applicant.
