## **General Terms and Conditions:**

Recreational Land Use Permits are subject to all general terms and conditions listed below, as well as any special stipulations that may be imposed by TKC. Applicants should check with the TKC land office if interested in information on other permits. This permit is for overland access across TKC lands only. This permit applies to non-shareholders. TKC shareholders do not need a permit to cross TKC lands.

- 1. Applicant acknowledges that lands subject to permits by The Kuskokwim Corporation (TKC) are owned by the corporation.
- 2. Applicant agrees that any use occurring under permits will be for personal uses only, and will not be commercial.
- 3. Applicant agrees to indemnify and hold TKC harmless from any and all legal liability which may be asserted against the permit holder or TKC by virtue of the issuance or use of a permit.
- 4. Permit holders agree not to leave any refuse or other material on TKC lands, nor to place the same on any water body. Permit holders further agree not to disturb the natural habitat.
- 5. Each permit is the property of TKC and must be surrendered to TKC upon request.
- 6. Permits are only effective for the period indicated on authorized permits.
- 7. Each permit is void unless signed and dated by an authorized agent of TKC and by the applicant.
- 8. Campfires are only allowed with the Camping/Campsite Permit. Land must be cleared to mineral soil to a minimum of two feet in diameter. Campfires are not permitted on mossy or organic soils. Fuel is limited to down and dead wood. Permit holder agrees to completely extinguish campfires before vacating an area and agrees that he/she is liable for costs and damages caused by uncontrolled campfires.
- 9. Hazardous materials (Environmental Protection Agency and State statute definitions; fuels and petroleum-based lubricants) are not to be stored or handled on Corporation property. Any fueling operations are to be undertaken off Corporation land. Any spillage on Corporation land shall be immediately and thoroughly cleaned-up and removed from Corporation property, and disposed of according to applicable laws, regulations, and good judgment. Notification of such an incident shall be made to the Alaska Dept. of Environmental Conservation according to applicable law; and to The Kuskokwim Corporation.
- 10. All motorized vehicles with the exception of three or four wheelers are restricted to specific trails.

- 11. Applicant shall observe all applicable federal, state, and local laws and regulations, and shall be responsible for obtaining any applicable licenses.
- 12. This permit is for access to cross over TKC lands only. Prolonged stay longer than 24 hours, or any sort of logging or wood collection is not authorized under this permit.
- 13. This permit is not valid during the dates of Sept. 1- Sept. 20<sup>th</sup> due to access restrictions for moose hunting activities.
