The Non-Shareholder Award recognizes the contributions of a non-TKC shareholder within the region. The Elder Award recognizes a significant Elder from within the region. This is your opportunity to show hardworking, dedicated and committed shareholders (and non-shareholders) how much they are appreciated. If you know of any individual deserving of this type of recognition, please nominate them. Awards will be presented to five individuals during the Annual Shareholders Meeting, June 4th, 2016 held in Lower Kalskag, Alaska. The five nominating TKC awards are listed below.

Award for Health

Nominees can be health aides, nurses, health board members, school board members, or any other individual who has shown dedication in the health field.

Award for Education

Nominees can be teachers, students, parent committee members, school board members, teachers aides, or any other individual who has demonstrated strong commitment, competence and sensitivity in the field of education.

Humanitarian Award

Nominees can be shareholders who have shown, through involvement and daily actions, compassion, kindness, and selfless giving of his or her time and energy to help other people.

Award Recognizing an Outstanding Non-Shareholder

This award recognizes the contributions of a non-shareholder whose actions demonstrate a passion and commitment to helping people within the TKC region.

Elder Award

This award recognizes an Elder shareholder whose contributions have continued to help make the region a better place.

The TKC Board of Directors will need to have the full profile when making their decision. Please nominate one person per category per form.
