**PERSONAL USE FIREWOOD APPLICATION SPECIAL CONDITIONS**

1. Each personal use timber cutting and use application must be approved, and a permit issued **before** any cutting or removal of timber from Corporation land is allowed.
2. This permit is for dead or downed timber suitable for use as firewood only.
3. Stump heights for standing dead wood shall be left no greater than 6 inches above the ground.
4. No more than 8 cords of dead or downed timber per application will be approved.
5. This permit does not allow the harvesting of house logs.
6. This permit does not allow for the harvesting of timber for use in wood fired boilers. The amount of wood needed to operate these units is considered a commercial amount of harvest under this permit. Wood obtained for boilers must be permitted under the Logging permit.

INDEMNIFICATION: APPLICANT’S FITNESS AND EXPERIENCE:

1. The Applicant represents to TKC that he/she is fit, willing, and has sufficient prior experience to undertake the activities authorized by this permit, that he/she is familiar with the physical requirements and hazards, whether natural or otherwise, which are inherent in the activities authorized under this agreement, and that he/she specifically recognizes and acknowledges that the use of mechanical equipment, including chain saws, axes, and tracked and wheeled vehicles in this activity involve inherent potential risks to life, limb, and property if not properly and safely handled by persons experienced in these activities. The Applicant and its signatory to this permit, by his/her execution of this agreement, represents to TKC that he/she, and any other party assisting him/her with the activities are sufficiently experienced to enable the authorized activities to be conducted reasonably and safely, with due regard for the protections of persons and property.

CORPORATION APPROVAL:

This permit is valid for twelve (12) months from the date of approval and may be cancelled by the Corporation if it appears to the Corporation that the information supplied by the Applicant is incorrect, or if it appears to the Corporation that the terms and conditions of this permit have not been met by the Applicant.
