IMPORTANT NOTICE REGARDING DELIVERY OF SHAREHOLDER DOCUMENTS

In order to save paper and reduce significant printing and mailing costs, The Kuskokwim Corporation (“TKC”) offers the following option:

You may choose to receive one set of printed Annual Meeting materials per household, rather than receiving a printed set of Annual Meeting materials for each Shareholder in your household. This consent is optional. You may revoke consent at any time by sending a signed and dated written notice to TKC Shareholder Services Department at the address below. You may also call (800) 478-2171 or (907) 243-2944 at any time to revoke consent and receive mailed copies of meeting materials. Following receipt of your request, TKC will thereafter provide one set of printed Annual Meeting materials to each Shareholder requesting an individual copy during the next scheduled distribution of Annual Meeting materials.

Annual meeting materials include: annual report, guide to the annual report, notice of annual meeting, agenda for annual meeting, proxy statement, proxy form, instructions for filling out the proxy form, proxy prize sheet, instructions for electronic transmission of completed proxy, and other items.

If you opt to receive one set of printed Annual Meeting materials per household, each Shareholder will still receive their own proxy in order to cast their individual ballots.
